PROJECT APPLICANT

Granada County Council

PROJECT OBJETIVES

The Provincial Council of Granada, in the framework of this project proposal will developed a project of social, educational and labor intervention, focusing on the thematic area of Roma with the following objectives:

- to raise awareness about and combat harmful stereotypes of Roma and supporting thereby their integration into mainstream society. Identification and exchange of good practices across fields of access to education, employment, healthcare or to housing as well as anti-discrimination, protection of Roma children and women and empowerment related to Roma integration.
- To promote collaboration and coordination among European entities in the design, implementation and assessment of intervention actions with Roma.
- To promote and encourage collaboration, participation and capacity building among European professionals, in particular for professionals specialized in Roma support. Roma culture, attention to diversity, gender equality and marginalization and discrimination (using NTIC)...

- training and cooperation of relevant professionals (health and house services, police, the judiciary, social workers, teachers, employers, trade union representatives, university staff etc.) to better prevent and respond to non-discrimination, including through the establishment of formal or informal procedures and support programmes to respond to cases;
- mutual learning, exchange of good practices, cooperation, including identifying best practices which may be transferable to other participating countries;
- Dissemination and awareness raising activities (including at local level), such as seminars, conferences, campaigns or social media and press activities.

- The integration of the Roma in the social, health, labor and education scopes.
 - Training of professionals and unemployed Roma population.
